## **Arts and Music in Schools Funding Guarantee and** Accountability Act -**Proposition 28**



## Intent of the Funding

To increase access to arts education for all students.

Funds received will be used to supplement funding for arts education programs rather than used to supplant funding for existing



arts education programs.

# The Essentials of Comprehensive Arts Education Programs

- For students to develop into artistically literate, creative, and capable individuals, it is essential that arts instruction is sequential, standards-based, comprehensive, and prioritized.
- Comprehensive means standards-based sequential instruction for all students, in all five arts disciplines, during the regular school day, each year from TK through grade twelve is prioritized.
- Access to each of the arts disciplines
   (dance, media arts, music, theatre, and
   visual arts) through articulated feeder
   programs that support transitions
   between school levels to continue
   learning in the arts without interruption.

## **Background Information**

This act ensures every student in California's K-12 public schools has access to a high quality arts education by:

(1) Increasing and stabilizing funding for arts and music education so that schools can develop and maintain a high-quality course of study in arts and music—year after year

- (2) Holding public officials accountable for using such funds for arts and music education
- (3) Doing all of this without raising taxes

**Proposition 28 will** provide K-12 public schools (including charter schools) an annual allocation for arts and music programs beginning with the 2023-24 fiscal year.



Beginning in 2023-24, the measure requires the state to provide additional funding to increase arts instruction and programming in schools.



The amount would be equal to 1 percent of Proposition 98 funding that K-12 schools received in the previous year, as part of the May Revision of the Governor's Budget



This funding would be considered a payment above the constitutionally required amount of funding for schools (*Prop 98*).



The funding will be allocated directly to LEAs (school districts), with 70% of the share based on LEA enrollment in the prior fiscal year and the remaining 30% based on their percentage of low-income students.



LEAs (school districts)
will be required to
distribute funds to
their school sites
based on those
specified calculations.



At each School site or preschool, the principal or program director shall develop an expenditure plan for the funds. Sec. 8820(e) Each school can determine which program or programs it will offer. School administrators—in collaboration with teachers, families, and students—should together make the choice that best serves students in their local school community.



When the funds are allocated to a district, the district may use no more than 1% for administration. The remainder must be allocated to the schools in an amount equal to the amount received by the district for each school.

LEAs must submit an annual board-approved report in a manner determined by the Superintendent (State Superintendent of Public Instruction) certifying that the funds were used for arts education programming and post how funds were spent on their websites. Sec. 8820(g)(4)





Schools will have three years to spend the funds they receive each year.
CDE will reallocate any unspent funds to all schools in the future.





The CDE will send the funds to school districts in February.

These funds will be in the Principal's Apportionment.

 The study measures the degree to which students have an opportunity to complete standards-based, sequential arts education K-12 in all arts disciplines.



#### Creativity Challenge: The State of Arts Education in California

11%

State law requires all students receive sequential, standards-based visual and performing arts education, but only 11 percent of schools are meeting that requirement.



Insufficient funding and a lack of training for teachers remain the biggest barriers to providing excellent arts education throughout the state.



14% of schools with mostly low income students offered all 4 four disciplines, compared to 32% of schools with majority affluent students.

## **How Teachers & Advocates can support Prop 28**

## What to keep in mind...

- Voters overwhelmingly agreed: "Arts education is an educational priority worthy of the state's commitment to a minimum funding guarantee"
- "Funds received will be used to supplement [i.e., expand] funding for arts education programs"
- The Proposition author, Austin Buetner, stressed the importance of community engagement to decide how funds are to be spent.


